## PURPOSE:

Four points in the SWAN Bulletin will be modified through this special transmittal:

- 1. the release of SWAN-paid family profiles to other states for the adoption of foster children,
- 2. the number of contacts required for completion of the child preparation unit of service,
- 3. the permanency options that an eligible family can provide, and
- 4. the child population that SWAN serves.

## BACKGROUND:

## Family Profile

Pennsylvania intends to further promote and support cross jurisdictional permanency for children in the United States and is revising the policy on the release of family profiles completed and paid by the SWAN prime contractor to other states.

#### **Child Preparation**

The revised SWAN bulletin issued on January 1, 2003 contained a typographical error that needs to be corrected.

### **Eligible Families**

The revised SWAN bulletin issued on January 1, 2003 did not include all permanency options that an eligible family could provide to a child.

### **Child Population Served**

The revised SWAN bulletin issued on January 1, 2003 contained a typographical error that needs to be corrected.

### **DISCUSSION:**

### Family Profile

Currently the bulletin requires families to purchase the SWAN-paid family profile at a cost of \$2,500 if they choose to adopt a child other than a child in the Pennsylvania foster care system.

Pennsylvania is now revising Attachment F-1 to allow the release of family profiles in cases where families request that their SWAN-paid approved family profile be forwarded to another state for the purpose of adopting a child from that state's foster care system. The repayment plan for this family profile is described in the special transmittal on page 2 of Attachment F-1.

#### **Child Preparation**

Currently, in the Child Preparation Enhancements on page 19, the bulletin states, "It is expected that the assigned professional will meet with the child for a *maximum* of 10 meetings over a 6-month period."

That statement should read, "It is expected that the assigned professional will meet with the child for a *minimum* of 10 meetings over a 6-month period."

Please replace page 19 in the current bulletin with the enclosed revised page.

#### **Eligible Families**

Currently, the definition of an Eligible Family on page 6 of the bulletin states, "Permanency includes adoption, kinship care and Permanent Legal Custodianship."

This statement now includes all the permanency options a family can provide. It should read, "Permanency includes adoption, permanent legal custodianship, or placement with a fit and willing relative (formal kinship care)."

Please replace page 6 in the current bulletin with the enclosed revised page.

### **Child Population Served**

Currently, the definition of Child Population Served on page 6 of the bulletin states, "SWAN serves children who are in the legal custody of county agencies and/or have a court-ordered goal of adoption."

The statement should read, "SWAN serves children who are in the legal custody of county agencies whether or not they have a court-ordered goal of adoption."

The following statement should be added to child population served, "These children may have any permanency goal."
